### We Are Open For Business!



We are pleased to announce that effective April 5th, all Palisades Credit Union branches are now open during regular busines hours (see page 4 for hours and locations), without the need for an appointment. We are doing everything we can to ensure a safe environment for our members and employees, including limiting lobby capacity and requiring the use of face coverings. When visiting a branch, please adhere to the lobby capacity posted on entrance doors. Many members have adapted to using electronic channels, such as mobile deposit and ATMs, for complete basic transactions; these options remain available and are encouraged to help reduce wait times. We appreciate your understanding and patience over the last several months and look forward to seeing you in a branch soon!



## **Rewards Checking Changes**



Effective June 1st, our rewards checking offerings are changing to make earning more rewards even easier. Members with Kasasa checking accounts will be automatically converted into our new program. Kasasa Cash accounts will be replaced with a new high yield product offering 3% APR\* on balances up to \$10,000. Kasasa Cashback accounts will be replaced with a new cashback product offering that will pay up to 1% cashback on total purchases up to \$1,500. To qualify for rewards, members will need to be enrolled in e-statements, have at least one ACH deposit each month, and make at least 12 debit card purchases during the each monthly cycle. Qualifying members will also be eligible for ATM refunds of up to \$18 each month. An email will be sent out to members that currently have Kasasa accounts detailing the changes prior to the conversion in June.
